Ms. Howard, I have contacted the director of our teacher licensing team multiple times requesting an update on the status of this investigation. I have not received that information yet so it is premature to assume that nothing has/is being done. Our teacher licensing team is one that is extremely busy so it is not out of the ordinary for it to take some time for a response.

I will share with you that the typical process DPI employs when faced with these types of issues/complaints is to work with the authorizing district (or independent charter school) to devise a plan for getting the teachers in question appropriately licensed or to get appropriately licensed individuals in those respective roles. This is likely the course of action that has been taken regarding this situation. But, again, I have not received word from the director as to the exact course of action that has been undertaken so I am simply making an assumption based on information that has been shared with me in the past regarding how these types of issues are generally handled.

I will update you when I receive an update.
